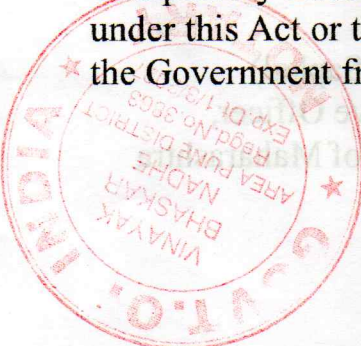

Shri. Vallabh Welfare Foundation, Narayangaon, Pune, has submitted an application for starting a new school on self-financing basis at Bloomingdale International School, Group No. 110/1, 110/2, 110/3, 113/1, 113/2, 114/2, Village Bhorwadi (Yedgaon), Tal. Junnar, Dist. Pune (Primary to Higher Secondary, Grade 1 to Grade 12, All Branches, English Medium, CBSE) under the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 and the Maharashtra Self-Financed Schools (Establishment and Regulation) Rules, 2020, from the academic year 2022-2023. Vallabh Welfare Foundation, Narayangaon, Pune has given a letter of intent to start a new school on self-financing basis, Bloomingdale International School, Group No. 110/1, 110/2, 110/3, 113/1, 113/2, 114/2, Mouje Bhorwadi (Yedgaon), Tal. Junnar, Dist. Pune (Primary to Higher Secondary, Grade 1 to Grade 12, All Branches, English Medium, CBSE), under the reference, along with terms and conditions. The said school is now being granted a letter of recognition subject to the following terms and conditions from the academic year 2024-25.

3. Terms and Conditions:-

1) The proposed school shall comply with all the standards, terms and conditions prescribed by the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 and the directions given by the Government under this Act or the standards or standards or terms and conditions specified by the Government from time to time.



2) The registered institution or trust or company shall comply with all the standards, terms and conditions prescribed by the Maharashtra Self-Aided Schools (Establishment and Regulation) Act, 2012 and these

It is mandatory to comply with the directions given by the Government under the Act or the standards or terms and conditions specified by the Government from time to time.

3) It is mandatory for the school managements desirous of affiliation to the Boards like C.B.S.E. or C.I.S.C.E. or C.A.I.E. or I.B. etc. to obtain a no-objection certificate from the Government as per the directions given by the Government from time to time.

4) The school management shall inform the Education Officer of the concerned District before the commencement of the academic year approved by the Government.

5) The permission granted under the provisions of this Act to establish a new school or to upgrade the status of a school shall be for the same academic year for which it is approved.

6) If the school management fails to start the school within 18 months, the recognition granted shall be cancelled.

7) The school management shall not be able to change the approved medium of education, location of the school, in future without the permission of the Government.

8) If the school management has established a school at a place other than the place approved by the Government, the permission of that school will be cancelled.

9) It has been provided that the recruitment of teachers and non-teaching staff in self-financed schools should be done as per the prevailing rules and regulations of the Government.

10) While filling the district-wise information, the school to which permission has been given. That school will fill the information as "Self-financed School" as a separate category and will obtain U.D.I.S.E. number. In this regard, the State Project Director, Maharashtra Primary Education Council, Mumbai has been declared as the nodal officer.

11) The school management will put up a board saying "Self-financed Permitted School" at the entrance of the school premises.

12) The State Government may, at any time, cancel the certificate of recognition granted on the ground of violation of any of the provisions of this Act or the rules made thereunder or failure to comply with any directions given under the Act or with any standards or standards specified by the Government from time to time or with any terms and conditions.
